

# Product Update

With effect from 5pm on Tuesday 21st November 2017, L&G Home Finance will be removing the £1,999 arrangement fee from their Premier Flexible plan and they will be changing the rates.

## WHEN WILL THESE CHANGES TAKE EFFECT?

## PIPELINE CASES

To secure the current interest rates:

- You must generate the KFI by 5pm 21st November 2017
- You must submit the application by 5pm 28th November 2017
- The valuation needs to be carried out by 19th December 2017
- All supporting documentation required, must be with us by 21st December 2017
- The case needs to be offered by 28th December 2017
- Completion will need to take place within the 50 day offer validity period.

If an offer expires and you'd like us to reoffer the case on one of these new rates, you don't need to provide them with a new KFI. Instead you can fill out [this short online form](#) and they will do the rest. You'll need the account number which you will find on the original mortgage offer.
